**Physical state** : Viscous liquid.  
**Odour** : Mild petroleum oil like.

## 4 . First-aid measures

- Eye contact** : In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention if irritation occurs.
- Skin contact** : Wash skin thoroughly with soap and water or use recognised skin cleanser. Get medical attention if irritation occurs. Remove contaminated clothing and shoes. Wash clothing before reuse. Clean shoes thoroughly before reuse.
- Inhalation** : If inhaled, remove to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. Get medical attention.

## 5 . Fire-fighting measures

- Flammability of the product** : May be combustible at high temperature.
- Products of combustion** : Carbon oxides (CO, CO<sub>2</sub>), nitrogen oxides (NO<sub>x</sub>), sulphur oxides (SO<sub>x</sub>), phosphorus compounds (PO<sub>x</sub>), calcium oxides (CaO<sub>x</sub>), zinc oxides (ZnO<sub>x</sub>), aldehydes, ketones, hydrocarbons, smoke and irritating vapours as products of incomplete combustion.

### Extinguishing media

- Suitable** : Use an extinguishing agent suitable for the surrounding fire.

## 6 . Accidental release measures

Do not touch or walk through spilled material. Avoid breathing vapour or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. - Methods for cleaning up** : Stop leak if without risk. Move containers from spill area. Approach the release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product. ## 7 . Handling and storage

- Handling** : Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk. Evaporate the residue under a fume hood. Ground all equipment containing material. Do not ingest. Do not breathe gas/fumes/vapour/spray. If ingested, seek medical advice immediately and show the container or the label.
